



# CHINON CLASSIC REGULATIONS

## JUNE 20, 21 and 22, 2025

### Article 1

The Chinon **Classic Association organizes**

- A Historic Tourist Hike, without fixed times or imposed averages, reserved for vintage cars from **1900 to 1994** (over 30 years old)
- A PRESENTATION OF OLD CARS AND MOTORCYCLES ON CLOSED ROADS IN CHINON

The Ride complies with the general provisions of the Fédération Internationale des Véhicules Anciens (F.I.V.A.). **It is in no way a sporting event.** Its purpose is to allow collectors of vintage vehicles to run their vehicles while bringing to life the industrial heritage that these vehicles constitute. It also promotes the discovery of the landscape, architectural, cultural and historical heritage of our regions. The hike is organized so that each participant, whatever the age and engine capacity of their vehicle, can complete the route in good conditions.

It takes place on an open road, in compliance with the Highway Code, with the aim of not disturbing the circulation of other road users or the tranquility of local residents and will not give rise to any classification based on navigation and/or regularity.

The departure of participants is staggered so as not to disrupt road traffic.

### Article 2 Cars Eligible for the Event

All old cars in perfect working order, holder of a registration document and insurance whose characteristics conform to the original, being over 30 years old (unless exceptional exemption granted by the organizers). The hike is also open to "SUPERCAR" cars less than 30 years old. The CHINON CLASSIC association reserves the right to refuse any vehicle which does not conform to the spirit of the event. **Any change of vehicle must be immediately reported to the organizers who reserve the right to accept or refuse the said vehicle.**

### Article 3 Obligations

Participants must comply with the requirements of the highway code, municipal and prefectural decrees, as well as the articles of these regulations. In addition, they must respect the signs which may possibly be made by the marshals.

***The visible rally plate is mandatory on the vehicle and must in no case obscure the vehicle registration.***

**It is imperative to indicate on the registration form, Name, First name and telephone number of the person to be notified in the event of an accident.**

### Article 4 Insurance

In accordance with the requirements of decrees 2006.554 of 05/16/2006, and its implementing orders of 08/7/2006 and 10/27/2006, a policy will be taken out to guarantee (in the event of an accident, fire or explosion occurring during demonstrations) the financial consequences of civil liability that may fall on the organizers and competitors, due to bodily injury or material damage caused to spectators, third parties or the competitors themselves. This policy also guarantees civil liability towards the people responsible for security or participants in the organization and control of the event.

It is up to participants to check with their insurers that their various insurance contracts remain valid for the duration of the Hike. If this is not the case, it is up to them to take all measures to cover the pilot and navigator against the risks of the Hike.

### Article 5 Advertising

The organizers reserve the right to make the agreements they deem useful with the advertising brands of their choice and to affix this advertising on the plates bearing the participants' numbers or on the cars. Any other advertising, other than that decided by the organizers, is strictly prohibited (unless agreed by the organizers).

### Article 6 Withdrawal of files

Participants will report to the competitors reception to collect the necessary documents (program, detailed itinerary, rally plate), as desired.

FRIDAY at 2:00 p.m.,

SATURDAY from 7:30 a.m. to 8:30 a.m.

SUNDAY from 8 a.m. to 8:30 a.m.

## Article 7 Procedure

The event will take place in the tradition of courtesy and kindness which are the rule among vintage car enthusiasts.

### THE TOURIST RALLY

The tourist hike will include a route which will mainly take secondary roads in our region.

**The start will be given at 8:45 a.m.** on Saturday. The participants in the hike do so under their sole responsibility, as it is a tourist hike, **without any sporting aspect**. Each participant is asked to respect the times indicated on the road book.

### PRESENTATIONS / DEMONSTRATIONS

Only motorcycles and cars registered for the event will be able to participate in the demonstrations on Saturday afternoon and Sunday. This is a presentation of homogeneous vehicles in series of 20 to 30 (in no case of speed or regularity tests). The competitors will present themselves in a Chinon Classic plate pre-grid visible a quarter of an hour before the start of their series. Out of respect for the public and sponsors, unless agreed by the organization, participants undertake to stay throughout the entire Sunday event.

**No overtaking is authorized or risky behavior for people on board under penalty of being immediately excluded from the circuit.**

**Car registrations only for the Sunday demonstration are limited to pre-war vehicles or by selection of the organization.**

## Article 8 Commitments:

**No commitment or registration will be made over the phone.**

Only the registration document available on <https://www.chinonclassic.com>, received by the organization will be registered. Your participation in the event will only be taken into account once payment has been received, a confirmation of commitment will then be sent to you. Any request for participation must be sent to:

**For the first participation, a photo of the vehicle is mandatory. For the Saturday rally, the closing will take place as soon as the number of participants is reached depending on the reception capacities of the different places visited. The organizers reserve the selection of entries, giving priority to pre-war vehicles and vehicles older than 1960 and refusing any vehicle that does not correspond to the spirit of the event.**

## Article 9 Regulations:

=> in cash: for foreigners who wish, send a deposit check in the currency of the country returned in cash on the day of the event.

## Article 10 terms of cancellation:

Any cancellation by the participant must be notified in writing (mail or email) before June 10 in order to obtain a refund of the amounts paid. In the event of cancellation after this date, no refund will be made. All cases not provided for in these regulations will be decided by the organizing committee, bringing together those responsible for the Chinon Classic.
